- 3. Online application once submitted cannot be altered / resubmitted under any circumstances. Further, no request with respect to making changes in any data / particulars entered by the candidate in the Online Application will be entertained, once the application is submitted successfully.
- 4. IKGPTU, Kapurthala Campus will be Head Quarter for all contract Posts and are transferable within IKGPTU Campuses (Main Campus, Amritsar, Mohali and Hoshiarpur) under the Jurisdiction of I.K Gujral Punjab Technical University.
- 5. The appointment as Faculty (purely on Contract Basis) will be for a period of 11 months.
- 6. Selected candidates shall be paid a consolidated salary of Rs. 50,000/- per month.
- 7. It is mandatory to upload the reservation/caste certificate.
- 8. Selection committee may have the right to declare the candidate "Not Found Suitable" (NFS) on the basis of his/her performance in the interview.

- 14. Selected candidates shall take full teaching load as prescribed in the curriculum and administrative load as assigned by IKGPTU.
