In pursuance of the provisions of sub-section-(1) of Section 18 of the I.K.Gujral Punjab Technical University Act, 1996 (Punjab Act 1 of 1997) and all other powers enabling him in this behalf, the Governor of Punjab is pleased to issue the First Regulations for the recruitment/appointment of Registrar of IKG Punjab Technical University as under:-

Procedure for the appointment of Registrar in IKG Punjab Technical University

- A** As a first preference an IAS/PCS officer of the state may be appointed as a Registrar.
- B** In case the State Government is not able to make the services of IAS/PCS officer available then the following process shall be adopted.

1. Inviting applications for the post

The applications for the post of Registrar duly approved by the Board of Governors, IKGPTU shall be invited through open advertisement in the prescribed format through leading news papers. The same shall be posted on the University Website www.ptu.ac.in along with detailed eligibility criteria.

2. Minimum Eligibility

The minimum eligibility for the post of Registrar shall be as per Government of India, Ministry of Human Resource Development, Department of Higher Education, New Delhi Letter No.1- 32/2006-U.II/U(ii) Dated: 31st December, 2008, which is as follows:

"Master's Degree with at least 55% of the marks or its equivalent grade of 'B' in the UGC 7 point scale. Experience required for the posts of Registrar and equivalent shall be:-

- (i) At least 15 years' of experience as Assistant Professor in the AGP of Rs. 7000 and above or with 8 years' of service in the AGP of Rs. 8000 and above including as Associate Professor along with experience in educational administration. Or
- (ii) Comparable experience in research establishment and/or other institutions of higher education, Or
- (iii) 15 years of administrative experience, of which 8 years shall be as Deputy Registrar or one equivalent post.

2.1. Detailed Selection Criteria

The detailed selection criteria for the post is given in **Annexure -A**.

3. Age of Superannuation

The age of superannuation for the post of Registrar shall be 58 years.

4. Pay Scale

The pay scale of the Registrar in the university shall be as per letter No. 1-32/2006-U.II/U(ii) dated: 31-12-2008 issued by Government of India, Ministry of Human Resource Development, Department of Higher Education, New Delhi and the approval of Board of Governors, IKGPTU from time to time.

5. Tenure

As per PTU Act and subsequent approval of Board of Governors at its 52nd meeting, for the position of Registrar, the appointment shall be made by the Board of Governors on the recommendations of the Vice Chancellor for a period of 3 years which may be extended by another term of 3 years or attainment of age of superannuation, whichever is

earlier. All tenure posts shall be treated as on a contract basis. Appointment of the Registrar of the University shall be made strictly on the basis of merit.

6. Reservation

Reservation shall be applicable as per the State Government policy.

7. Screening and short listing of Applications

7.1 A Screening Committee will be constituted by the Vice Chancellor to scrutinize all the applications and shortlist the candidates as per following procedure:

- (i) Those not fulfilling the minimum eligibility criteria shall be rejected.
- (ii) The Screening Committee would further give marks as per the selection criteria given in the Annexure-A except for the presentation and interview marks.
- (iii) List of shortlisted candidates shall be put up on the University website www.ptu.ac.in.
- (iv) All shortlisted candidates shall be intimated for the interview through their email ids and correspondence address as mentioned in their application forms submitted.
- (v) The University shall not hold any responsibility for non-receipt of intimation on account of change in the correspondence address or wrong email ids.

7.2 Constitution of Screening Committee

The constitution of the Screening Committee shall be as follows:

- (vi) One Internal Dean as nominated by the Vice Chancellor IKG PTU.
- (vii) Two Registrars/Ex-Registrars of any State University/ Central University
- (viii) Two Senior Professors from State University/ Central University
- (ix) An academician representing SC/ST/OBC/minority/Women/differently abled categories to be nominated by the Vice Chancellor, if any of the candidates representing these categories is the applicant and if any of the above members of the selection committee do not belong to that category.

The Quorum required for Screening Committee will be four members. The Vice Chancellor shall nominate Experts in the Screening Committee from the panel of Experts approved by Board of Governors, IKGPTU.

8. Selection Committee

8.1 A selection committee will be constituted by Vice-Chancellor to make recommendations regarding selection of candidates as per following procedure:

- (i) The Selection Committee shall assess the candidature of the candidates as per the merit list prepared by the Screening Committee on parameters defined in the Selection Criteria.
- (ii) The shortlisted candidates shall make a 10 minutes presentation about his/her past achievements and his vision and likely contribution for the job profile laid down for the post of Registrar by IKGPTU.
- (iii) To ensure transparency, the presentation shall be video recorded.
- (iv) The Selection Committee shall then interview candidate as per the procedure it may devise.
- (v) The selection committee will give marks for presentation and interview as per selection criteria and then total marks of the candidates will be worked out for making recommendations for selection by the Committee.

8.2 Constitution of Selection committee

Selection committee will be as follows :-

- (i) Vice Chancellor, I.K. Gujral Punjab Technical University as Chairman
- (ii) Nominee of the Chancellor
- (iii) Nominee of the State Govt.
- (iv) Two experts nominated by the State Govt.

- (v) An academician representing ST/OBC/minority/Women/differently abled categories to be nominated by the Vice Chancellor or acting Vice Chancellor, if any of the candidates representing these categories is the applicant and if any of the above members of the selection committee do not belong to that category.

At least four members, including one outside subject expert shall constitute the quorum.

9. Final Selection of Candidates

The recommendations of the selection committee shall be placed before the Board of Governors, for approval.

Note:- First Regulations relating to other issues shall be issued in due course.

General Instructions and Guidelines for candidates regarding the post of Registrar and Controller of Examination, at IKGPTU Main Campus:

1. The advertised posts shall be governed by the IKGPTU norms.
2. Reservation Policy shall be as per Punjab Government norms (if applicable).
3. Candidates belonging to any reserved category have to submit a relevant certificate issued by the Competent Authority.
4. University Reserves the right not to fill the advertised post(s).
5. Separate application forms be filled up for different cadre positions along with the requisite fee.
6. The University reserves the right to call only the requisite number of candidates for an interview after short-listing with reference to the candidate's qualification, suitability, experience, requirement etc.
7. Original documents will have to be shown at the time of the interview or as and when asked by the University.
8. Canvassing in any manner would entail disqualification of the candidate.
9. Persons called for an interview shall not be entitled to TA/DA.
10. The decision of IKGPTU in the matters of selection and appointment shall be final and no correspondence in this regard will be entertained.
11. Mere satisfying the essential/minimum qualification required does not entitle a candidate to be called for an interview.
12. Incomplete applications, applications of ineligible candidates, applications without supporting documents and applications without hard copy and fee etc. shall be rejected without any intimation.
13. Application fee is Rs. 1200/- (Including GST) for General Candidates and Rs. 300/- (Including GST) for SC/ST candidates and is to be deposited as per the directions given while filling online application.
14. Submission of online application on or before 27/07/2022 is the sole responsibility of the applicant. Hard Copy with all relevant credentials duly self-attested by the candidate must reach **Incharge, Recruitment Branch, IKG Punjab Technical University, Jalandhar-Kapurthala Highway, Kapurthala PIN-144603** on or before 03/08/2022 by registered / speed post. The candidate must write the name of the post applied for on the envelope.
